# Step 1: Where We Started 2014 Medicare Records by Provider Type



### Step 2: Added Years

- Medicare files are available by calendar year so to take the date of hospice admission and look back 365 days typically requires two years of data.
- Therefore, to run 2014 reports, we combined 2014 and 2013 records to look back 365 days.
- To run 2013 reports, we combined 2013 and 2012 records to look back 365 days.
- We wanted to provide you the ability to trend physician patterns over a two year period from the beginning.

### **Definitions:**

- "Referral Physicians" appeared in the claims as the Primary Attending Physician for beneficiaries who received hospice – but the physician was not listed as the Primary Attending Physician for anyone in hospice.
- "Hospice Physicians" appeared in the hospice claims as the Primary Attending Physician – regardless of whether they appeared in other claims or not.
  - We thought it was important to distinguish hospice medical directors from others.
- If a physician did not serve any beneficiaries who received hospice, they are excluded from this report.

### **Definitions:**

- Report Summary: The 100 physicians with the most hospice admissions (one line / physician)
- Referral Summary: All referral physicians (one line / physician)
- Referral Detail: All referral physicians including multiple listings for each physician broken out by hospice (multiple lines / physician)
- Hospice Summary: All hospice physicians (one line / physician)
- Hospice Detail: All hospice physicians including multiple listings for each physician broken out by hospice (multiple lines / physician)

### **Excel Tips:**

- Consider using View / Freeze Panes to temporarily "lock" selected fields in view.
- Consider using Data / Filter to add filtering capability within the spreadsheet.

### • On the "Detail" worksheets, note the difference between these columns:



These columns summarize ALL beneficiaries in hospice (in this example, 66 unique beneficiaries received hospice) These columns are admissions specific to each hospice (in this example, 19 beneficiaries received hospice at Pikes Peak HPC)
